US Youth Soccer - Europe

Code of Conduct

Participants Agreement to Accept and Abide by Rules of the Program

Players, coaches and chaperones participating in the USYS Europe Program with US Youth Soccer are exercising a privilege afforded them by US Youth Soccer in pursuit of European, Regional and National recognition as youth soccer players. These players must exhibit the maturity to be successful in this pursuit. Thus, the following guidelines and rules shall apply in all activities within the Olympic Development Program.

1. GENERAL GUIDELINES:

Participants are expected to conduct themselves at all times in a manner which is in keeping with representing US Youth Soccer Europe and will not bring discredit upon the Association.

When traveling with the USYS Europe Program, each participant is expected to dress appropriately as befits representing US Youth Soccer or as directed by the Coach.

Respect for property of others, adherence to the rules and guidelines as specified here or by the Coach/Administrator and observance of State and Federal laws are required for participation in this program.

2. DISCIPLINE RULES:

1. Substance use and/or possession thereof [drugs, alcohol, or, in the case of minors, tobacco] is cause for immediate dismissal from the program.
2. Persistent irresponsible and disrespectful behaviour is cause for dismissal from the program.
3. Destruction of property or violation of State and Federal laws is cause for dismissal from the program.
4. Zero Tolerance on Hazing: defined as any activity that endangers the physical safety of another person, or produces mental or physical discomfort; causes embarrassment, fright, humiliation, or ridicule; or degrades the individual is cause for dismissal from the program and other programs of US Youth Soccer Europe.

ODP Europe Player/Parent Letter of Commitment

The purpose of Europe's Olympic Development Program (ODP) is to identify, develop and prepare our players for higher levels of competition (e.g. state, regional and national teams; collegiate and professional-level play). To achieve these goals, it is important that each player and his/her parent or guardian understand the level of commitment and code of conduct required to allow this caliber of program and players to be successful.

I, _____, (with a clear understanding of the time and financial obligations) hereby agree that it is my desire to play soccer at these higher levels and to adhere to the above philosophy and uphold the following regulations as set forth by Europe Youth Soccer and the Olympic Development Program for the 2020 seasonal year.

- As a USYS/ODP Europe State Pool player it is expected that you will attend all trainings & events to which you are invited. If you are going to miss trainings & events it is your responsibility to email the admin (Marcel Braun) as soon as possible prior to event (official dates on website) & cc Maribel Rodriguez. An absence will only be excused for a verified school event, injury or illness.

Each player is allowed to decline one USYS/ODP Europe event to which he/she is invited in the course of a USYS/ODP Europe season. For 2019/20 season the events are as follows:

1. USYS/ODP Europe Camp - November 2019 (Germany) U13-HS
2. USYS/ODP Europe Camp - January (Italy) for U13-U15 or College Showcase Camp for HS only (Germany) -January/February 2020
3. USYS/ODP Europe Camp - March 2020 (Germany) U13-HS
4. USYS/ODP Europe International Trip – U13-HS
5. USYS/ODP Europe Camp is scheduled for May 2020 (Germany) U13-HS

For the 2019/20 season each camp is priced at 275 Euro, except the College Showcase camp (550 Euro) and the international Trip (price varies depending on location and dates)

- Abide by the rules and directives of USYS/ODP Europe Youth Soccer, U.S. Youth Soccer, USSF and FIFA.
- Adhere to the training and competitive curriculum set forth by the USYS Europe/ODP Staff.
- Conduct yourself in a manner that will foster respect for Europe ODP (profanity, conduct, dress, etc.).
- Pay all fees [in a timely manner] as required by Europe Youth Soccer, ODP and other individual team commitments.
- Be respectful to teammates, opponents, officials, spectators and the coaching staff.
- DO NOT use alcohol, tobacco products or any other illegal substances at any time.

Europe Youth Soccer emphasizes that our ODP teams should be examples to all players, coaches and parents statewide. We will show respect to everyone on and off the field. It is the duty of the player to adhere to these values.

USYS/ODP Europe State Pool players who do not abide by the above rules will not be qualified to participate in USYS Regional or National events.
